### Purchase of Australian Cheese Manufacturing Company

The MEGMILK SNOW BRAND Group (the "Group") hereby announces that it acquired 90% of the shares of Udder Delights Australia Pty Ltd ("UDA"), an Australian cheese manufacturing company, on September 29, 2017.

#### 1. Overview

The Group acquired 90% of the shares of UDA from Udder Delights Group Pty Ltd, which established UDA by spinning off its cheese manufacturing and sales business.

Acquisition price: AUD 14,000,400 (approximately JPY 1,239 million\*)

\*AUD 1 = JPY 88.47 (exchange rate as of Sept. 29, 2017)

#### [Purchase scheme]

- (1) Udder Delights Group Pty Ltd established a new company, UDA, and transferred its cheese manufacturing and sales business to the new company.
- (2) The Group acquired 90% of the shares of UDA.

Within the 90% stake, 45% was acquired by MEGMILK SNOW BRAND Co., Ltd. (the "Company") and the remaining 45% by Snow Brand Australia Pty. Ltd., the Company's consolidated subsidiary.

#### 2. Background and purpose

- (1) The Company is pursuing market expansion through borderless development of cheese as one of the themes of the Group Medium-term Management Plan 2019 (released on May 11, 2017).
- (2) Currently, the Group's cheese manufacturing bases are in Japan, Indonesia and Australia. The Group sells cheese in all three countries.

(3) UDA is based outside Adelaide in the state of South Australia. It manufactures and sells mould natural cheese, mainly white mould cheese.
We will further strengthen the foundation of our mould cheese business in Australia by bringing UDA into the Group. We will also pursue product development as well as marketing-strategy synergies with Snow Brand Australia Pty. Ltd.
