Notice of Establishment of a Joint Venture Company

MEGMILK SNOW BRAND Co., Ltd. (headquarters: Shinjuku-ku, Tokyo; President Masatoshi Sato, hereinafter the "Company") and Agrocorp International Pte Ltd (hereinafter "Agrocorp") announced that they have decided to establish a joint venture in Singapore to leverage the strengths of both companies. The main business of this partnership will be the manufacturing and sales of ingredients for plant-based food processing.

In the Medium-term Management Plan 2025, the Megmilk Snow Brand Group has positioned "creating seeds for new growth" as one of three pillars of its business strategies and laid out its plans for entering the new area of the plant-based foods.

Since the establishment of their first facility for extracting pea protein in Canada (Saskatchewan), Agrocorp, an international company that trades, processes and distributes agricommodities products around the world, has considered the expansion of their capabilities in the plant protein extraction business.

The joint venture company will set up a (wholly owned) manufacturing subsidiary in Malaysia to address rising demand for plant-based foods.
